- LIGHTING PLAN KEY NOTES**
- ① CIRCUIT CONTROLLED THROUGH AN ASTRONOMICAL TIME CLOCK, FOR COMPLIANCE WITH FBC FBC ENERGY CONSERVATION SECTION.
 - ② OVERRIDE SWITCH WITH PILOT LIGHT FOR CONTROL OF TIME CLOCK. COORDINATE EXACT LOCATION AND QUANTITY OF PUSH BUTTONS WITH OWNER AND ARCHITECT.
 - ③ PROVIDE WEATHERPROOF JUNCTION BOX FOR ELECTRICAL CONNECTION TO BUILDING SIGN. COORDINATE EXACT LOCATION WITH ARCHITECT AND OWNER.

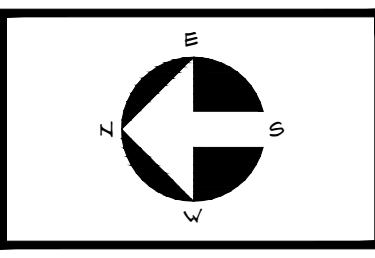

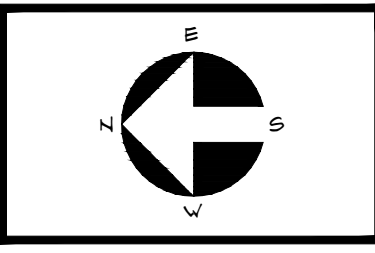
