    - iii) Plastic Laminate / Thermofoil wbG

Response: The Interior Designer / Wells Design Group indicates: 'The set of plans that the GC has; do not include specific information on products and/or areas where Wells Design Group is contracted to do the work. The GC is to go over ID-1 Floor Plan Scope of Work he will see that all information is provided there. All flooring, all decorative lighting, all moldings, all wall and ceiling coverings (interior)(tile, wall paper and/or paint), kitchen cabinetry, cabinetry in TV wall unit, men's and women's restroom cabinetry vanity and stalls are to be contracted through Wells Design Group. That is the reason why that information is not included. Anything that is not 100% specified in ID-13 is because Wells Design will do the work. Everything that is 100% specified in his set of plans (Bidding – Not for Contruction) is for GC to provide.

 Plumbing – Plumbing plans indicate pipe sizing for standard fixtures. ID drawings indicate flush-valve fixtures. Piping sizing conflicts with fixtures. Please clarify.

Response: S&A: Flush-valve plumbing fixtures are to be provided throughout. The plumbing drawings were to have been coordinated for 2" supply to flush-valve fixtures. The plumbing drawings will be revised accordingly.

3) Plumbing – Please confirm GC is to run 2" water service out to the existing water meter and b.f.p. Civil drawings indicates water service is existing with no parking lot patching required.

Response: S&A: From on-site observations made by the engineers, the water supply line is reduced from 2" to 1 ½" at some location between the water meter / back-flow preventer assembly and the building. The GC will need to provide an increase to 2" water supply service from the point of reduction to the building.

4) Electric – Please clarify if lightning protection will be required. It is noted on the specification page but not on the floor plan.

Response: S&A: A Lightning Protection system is not to be included in the project scope.

5) Electric - Please clarify if MC cable will be acceptable for use. Specifications do not mention.

Response: S&A: Provide only the electrical cable as specified on the plans.
